#### **REQUIREMENTS FOR THE PAPERS' SUBMISSION**

Languages of articles: Ukrainian, English, Polish, Bulgarian, Slovak, Russian.

**Volume of the paper** – 2-3 full pages.

**Text editor** – Microsoft Word; A4 format; portrait orientation; the fields – 25 mm; the font – Times New Roman, 12; line spacing – 1,0.

### **Requirements for the structural elements of the paper**

• Name and surname of the author(s) - font Times New Roman (font size 12), align center, without a paragraph, italics (if there are several authors, the names and surnames should be written in one line). Authors' data are provided in two languages (in the language of publication and in English).


• **The title of the paper** - Times New Roman font (font size 12). Submitted in bold, align center, without a paragraph, in two languages (in the language of publication and in English).

• **Abstract** - Times New Roman font (font size 9), italics, alignment - justified, paragraph spacing 0.63 cm, line spacing – 1,0. The main idea of the paper should be formulated in the abstract (the volume - 500-600 characters with spaces). Abstract is provided in two languages (in the language of publication and in English).

• **Keywords** - Times New Roman (font size 9), alignment - justified, italics, paragraph spacing - 0.63 cm, line spacing – 1,0. Keywords are provided in two languages (in the language of publication and in English). The number of keywords - 5-7, which are written through a semicolon.

■ **Main text** - Times New Roman (font size 12), paragraph 0.63 cm, alignment - justified, line spacing - 1,0.

• **Illustrations** (pictures and black and white photos). Pictures must be grouped. The font – Times New Roman, 12, italics. Pictures are denoted by the word "Pic." and are numbered successively within the report. If there is only one picture in the report, it is not numbered. Descriptive information, the picture number and its name are placed consistently under the illustration. *For example:*

• **Tables**. Tables' text size – font size 12. Tables' numerical heading (font size 12) is aligned to the right edge of the table, tables' thematic heading – centered (font size 12, italics). *For example:*

• **References**. The heading "References" must be placed in the centre of the line, the font – Times New Roman, 11, bold; and the list of sources – font size 11.

### It is needed to provide the author`(s`) data at the end of the paper (in two languages):

- name, surname font size 8;
- degree, academic rank, position of the author(s) font size 8;
- the place of work of the author(s) and the address of the organization font size 8;
- e-mail address of the author(s) font size 8.

Responsibility for the materials given in the publication is the responsibility of the author. Materials that do not meet the specified requirements will not be considered. The editorial board considers the receipt of the publication as the consent of the contributor(s) regarding the transfer of the copyright to the use of the work (replication, distribution, etc.).
