#### 1. General description of the Doctoral programme

Recent development of the world economy and international economic relations put governments and economic actors in a completely new environment, which is characterized by great heterogeneity and dynamic. The Doctoral Program "World Economy and International Economic Relations" provides an opportunity to explore the main economic processes at European and world scale, policy-making methodologies at international level, key actors on the political and economic scene, and the set of economic issues that arise for national economies and business entities.

#### 2. Educational goals

The aim of the doctoral programme "World Economy and International Economic Relations" is to prepare highly qualified specialists and researchers, who can independently develop and defend their projects through the use of scientific method of research and knowledge of real business practice and problems. The programme prepares the researchers to address the challenges of the modern international environment, and work in teams in the best academic traditions.

#### 3. Organisation and length of study

The doctoral programme "World Economy and International Economic Relations" is achieved through a set of courses and seminars with examinations in certain academic subjects, preparation and defense of doctoral thesis.

The curriculum requires two obligatory doctoral minimums for all forms of education, one for "International Economics", and the second is defined according the subject of the doctoral thesis. The connection between compulsory examinations and the chosen topic of study ensures the accumulation of basic knowledge in areas that are significant and relevant to PhD students.

The development of PhD students as researchers is supported by compulsory seminars and elective courses. The obligatory seminar is "Methodology of Scientific Research" divided in two courses: Part I and Part II part, and the courses on Applied Informatics and Foreign Language are optional.

The duration of the full-time and unsupervised doctoral programme is 3 years, and for part-time or distance study is 4 years.

#### 4. Knowledge

The studies in the doctoral program "World Economy and International Economic Relations" create specialized knowledge concerning the problems of the contemporary world economy, the different processes taking place in it, the policies on national, European and global scale, the operational environment of the business entities, the factors influencing the corporate activities and strategies for implementing international business.

#### 5. Skills

Doctoral studies in "World Economy and International Economic Relations" help build valuable skills for solving real-world issues; applying an interdisciplinary approach for solving practical problems; ability to process and select information, independence from external resources and external influence and conducting research.

#### 6. Competences

The studies in the doctoral programme contribute to acquisition of practical competences for autonomous strategic decision making at corporate and international level; building capacity for regulation of conflicts; increased flexibility and adaptability to time and location.
