I. General presentation of the dissertation:

The dissertation is structured, besides having an introduction an Conclusions with recommendations for further researchers, into four main chapters: 1. Chapter I is focused on the influence of the fiscal policy on economic development. ChapterII is presenting the results of the empirical research on effects of the fiscal policy on economics of the Republic of north Macedonia. Chapter III is on a strategic guidelines for a good management of the public finance (focused on the Fiscal strategy of the Republic. Finally, the Chapter IV is presenting some recommendations for improving the management of the public finance. Its volume is 214 pages without the list of literary sources and appendices.

In the doctoral research, the Candidate used a very rich sources, mostly from the modern literature on fiscal problems and economic development. Majority of the sources are from the contemporary western authors, since the problem is common for a most of the modern societies. The states are facing the problem, and the representatives of theeconomic science are producing a large scientific contributions which were taken into accountwhen preparing this Dissertation.

Our opinion is that the very rich list of figures and tables, following the main body of the dissertation and the Bibliography, gives an additional value to the work of mr Vesna Korunovska. Namely, there are some 48 figures and even 28 tables presented at the end of the doctoral thesis , The wide range of quantitative data and results are , in fact , a good basis for further researches and will give , for sure , an inspiration for the readers of the dissertation.

II. Assessment of the form and content of the dissertation.

1. Assessment of the relevance and development of research in the dissertation scientific problem
